DIFFERENCES BETWEEN FCI RULES & SPANISH RULES

- Categories
 - There will be 5 categories:
 - XS dogs under 28 cm, S dogs under 35cm, M dogs under 43cm, Intermediate dogs under 48cm and L dogs 48 cm and more.
- The minimum distance on the dog's path between consecutive obstacles should be 6 m. The maximum straight-line distance between consecutive obstacles should be 8 m and the maximum distance on the dog's path between consecutive obstacles never more than 10 meters.
- The actual length of the course must be between 100 m and 250 meters.
- In A1 class it's required that the dog traverse at least 15 obstacles, in A2 class at least 18 obstacles, and A3 class at least 20 obstacles, but never more than 22 obstacles.
- Course must be balance of skills and speed.
- At competitions that count for qualifying to Spanish Championship, where speed points are awarded, speed is determined in the Spanish agility rules.
- In A1 level the judge will determine the Standard Time. In A2 and A3 the Standard Time will be determined by the speed of the fastest dog with a clean run, multiplied by 1.25 in A2, and 1.15 in A3.
- The minimum speed in A1 class is 3,2m/s for Agility run and 3,5 m/s for Jumping run.
- In A1 class wall, tyre, long jump must be used at least once at the competition day.
- At Spanish Championship, Regional Cup or Breed Cup, following obstacles must be used at least one time at competition day: wall, tyre, long jump and double jump.
- At regular competition the same is recommended in A3 class (at least obstacles 20; wall, tyre, long jump, spread jump at least once during competition day).
- In Spain, in A3 level, double jump must be used in at least one run in a competition day.
- In Spain there are a Junior Class (U12, U15, U19) and a Senior Class (S55, S65).
- At the Spanish Championship these categories run their own courses, and at regular competitions these categories are competing together with everybody else (on the same courses).
- In Spain is possible that a dog competes in the lower height category. The decision to do so is up to the handler of the dog, but it must be confirmed by the Spanish kennel club. Once the dog starts to compete in the lower height category, it can't change back to higher height category, and dog's results will not count for qualifying for Spanish Championship or similar, but they can be on podium on that competition and qualifications of this day competition.
- The judging fees and expenses are established by the Spanish agility rules.
- The judge is entitled to: real travel expenses, accommodation, and maintenance expenses and judge's fee:
 - 50 euros for traveling days (without judging). Days before and after competition
 - 75 euros less than 150 runs
 - 100 euros 150 runs or more
 - 125 euros 200 runs or more
 - 150 euros 250 runs or more.

The judge could judge maximum of 300 runs.

- In Spain it is possible that, at same competition, one dog runs in different levels with different handlers. But that is only possible if the family (parents and children) is sharing same dog. The child must be under 12 years old.
- At Spanish Championship and tryouts, there will be an assistant judge appointed. This judge will help the
 main judge in situations where there is a clear mistake that main judge couldn't see. In that case, the judges
 can even use the video recording.
 - Is usual to have a camera recording the event, at Spanish championship and tryouts. Only those two judges can check the videos if necessary, and that should be done before the next handler enters the ring. The judges could stop and check the video as many times as feel necessary. The final decision, after reviewing the video, will be of the main judge.
- The aim of this document is to help foreign judges when judging in Spain, namely at competitions that count for the Spanish national championship.
- At AWC and EO tryouts the FCI rules will be applicable.
